Gift Aid is a simple scheme that enables Imperial College to reclaim the basic rate of tax on donations received from UK taxpayers, meaning that every £1 you donate is worth £1.25 to Just Gene Therapy. In addition, donors who pay a higher rate of tax are able to reclaim the difference between the higher rate and the basic rate in their Self-Assessment Return, bringing the cost of your gift down to 75pence in the pound, while still making the gift worth £1.25 to Just Gene Therapy.
